



# History and Heritage Branch – Air Force Privacy Notice for the use of Eventbrite

The History and Heritage Branch – Air Force (HH-AF) (**US/WE/OUR**) will in the event registration form collect personal information as defined under the *Privacy Act 1988* (Cth) (**the Privacy Act**).

## Purpose of collection

We are collecting your personal information to permit visitation to:

- RAAF Museum, RAAF Base Point Cook, Point Cook Road, VIC, 3027 and/or
- RAAF Base Amberley Aviation Heritage Centre, RAAF Base Amberley, South Amberley Road, Amberley, QLD, 4306.

## How will we collect and store the information?

- We are using Eventbrite Inc. (**Eventbrite**), a third party located in the USA, to collect your personal information through Eventbrite's website <https://www.eventbrite.com.au/>.
- Eventbrite will store your personal information in a password-protected account that may only be accessed by our authorised officers. Eventbrite may use your personal information for various purposes stated in [Eventbrite's Privacy Policy](#), including for marketing. You may contact Eventbrite about opting out of marketing communications by following instructions in their Privacy Policy.

## What we collect

The information we collect from you through Eventbrite includes your:

- Full name and email address
- Mobile number
- Vehicle registration details
- Postcode

## Who is Eventbrite?

Eventbrite is a ticketing and registration platform based in California, USA. You can find [Eventbrite's Privacy Policy](#) on the Eventbrite website.

Please note, Eventbrite is **not** bound by the Australian Privacy Principles under the Privacy Act (**the APPs**). If you consent to Eventbrite collecting your personal information on our behalf, we will not be liable for any act done by Eventbrite which is a breach of the APPs and you will not have any remedies under the Privacy Act by any act done by Eventbrite.

Eventbrite's Privacy Policy states they may use your personal information for internal business purposes as well as marketing and advertising purposes. They take what they believe to be reasonable steps to protect personal information collected from loss, misuse, unauthorised use, access, inadvertent disclosure, alteration and destruction.
